## **INFORMATION ON HOW TO ENTER THIS EVENT:**

### **WHO MAY ENTER**

Any current financial member of Sports Car Club of New Zealand Inc. including Life, Full, Associate, or Family member.

No member under 12 years of age may run in this event.

Members under 19 years of age must have signed confirmation on the Entry Form, by their parent or legal guardian, that they have permission to drive in this event.

**A separate Entry Form is to be completed by each Driver.**

### **VEHICLE COMPLIANCE REQUIREMENTS**

The vehicle compliance requirements for this event are detailed on the Entry Form. Your vehicle should generally be up to WoF standard, or if a dedicated motorsport vehicle, be in general compliance with the requirements of Schedule A of MotorSport NZ's Motorsport Manual. The mechanical standard of your vehicle is **YOUR RESPONSIBILITY!!!**

### **CARRAIGE OF PASSENGERS**

Passengers may be carried in this event, but **ONLY** if the vehicle and driver/passengers comply with the requirements of the NZ MotorSport Manual, Appendix 5, Schedule C, Part 1, Article 6.2. Each passenger **MUST** read and sign the Passenger Declaration **PRIOR** to the event commencing. The Passenger Declaration will **NOT** be available for signature after the event has commenced.

### **PERSONAL SAFETY CLOTHING & EQUIPMENT**

Your personal safety equipment should consist as a minimum of a serviceable Protective Helmet, designed for use in Motorsport, or for use with a motorcycle. You should wear protective overalls of cotton, or other non-flammable material, either single, or multi-layered and tight fitting at the neck, wrists and ankles. Footwear should be lace-up and provide complete coverage of the feet. Vehicle safety belts or safety harnesses must be worn at all times when on the circuit.

### **EVENT ENTRY FEE & CONDITIONS OF ENTRY**

No entries will be accepted on the day of the event:

#### Cash Entries

- \$150/\$180\* - for entries received up to the last working day prior to the event, where the entry is accompanied by **cash**.

#### Direct Credit Entries

- \$150/180\* - for entries where the entry fee is paid by Direct Credit, that entry must be received **not later than 3 (three) working days** prior to the event. The entry fee in this case, must be received within 3 (three) working days of the receipt by the Club of the Entry Form for that entry to remain valid.

While all Entry Fees above are generally non-refundable, part or all of any Entry Fee received may at the absolute discretion of the Organising Committee, be refunded where a competitor is unable to attend for any reason. A refund will normally only be considered, if notification of non-attendance is received by the Event Secretary **at least 7 working days** prior to the start of the event. Where notification is received less than seven working days prior to the event, no refund will be possible.

### **HOW TO ENTER**

- Entries will be accepted and processed as detailed above. Entries will be processed in the order which they are received. For an entry to be processed, both the Entry Form and the Entry Fee must have been received.
- Entries will only be acknowledged via email.
